Logic & Instructions: Eligibility for Third and Final Round of On Line Allocation:
LL.B.-5 Yrs.-2018-19

Reference: - Government Resolution No. CET-2018/ C.No.294 C.E-2, Dated 16th August 2018

A) Conduct of CAP Round-III. —

- (a) The seats available for The Last On Line Centralized Admission Round shall be published on the website www.mah-llb5admission.in on or before 21st August 2018.
- (b) The Candidates are allowed to Fill in or Edit the already filled On-line Option Form.
- (c) The Candidates who do not change their Personal Information and/or Academic Information and edit only Option form, their Merit No of the First Merit List for First and Second Round will be maintained in the Third Round.
- (d) To participate in the Last on line CAP Third Round of Admission, it is mandatory, for all the candidates & those who have Freezed their admission in the First & Second Round & are desirous of seeking admission in new college of their choice, to fill the Option Form & Approve for Third Round. If the Status of the Option Form of the Candidate is Unapproved for Third round, such candidates will not be considered for Third Round of Allocation
- (e) Candidates who have not been allocated seat in any of the previous rounds and whose CAP and Options forms are complete and approved may choose to edit their option form. If they do not edit their option form their existing options will be considered for the third round. Also candidates who have Freezed their admission in any of the previous rounds and do not edit their options forms and/or Personal and/or Academic forms will not be considered for Third Round allocation.
- (f) The candidates who had registered themselves for CAP process for First and Second Round but their names were in the On Hold List and had not cleared the discrepancy in the Grievance Period given before the declaration of the First Merit List will be able to complete their application, upload the documents and give preferences. But such candidates will be included in the new Merit list for Third round after the candidates in the first Merit list. The candidates who had filled in the Application form and or Option form but had not submitted and approved it will be able to do so before the start of the Round III. All these candidates will be included in the new merit list for Round III.
- (g) Candidates should remember that this is the Last and Final Round of On Line Centralized Admission Process conducted by CET CELL/DHE.
- (h) Hence, Candidates should be extra careful about editing the Option Form.

- (i) Candidates who have not been allotted any seat in any of the previous rounds or who did not participate (failure of filling option form) in previous round or those who have taken and cancelled their admission in the earlier rounds or rejected seats and those who have Freezed the admission in earlier rounds but are desirous of Floating in this final round are eligible to participate in this Round;
- (j) Candidates who have opted for Freeze Option and also applying for this third round shall not fill in the allotted institution in their choice list. It will be added by the software at the end of the list. Once the upward allotment is made the earlier allotment automatically stands cancelled due to Dynamic Allocation, hence the candidates should give their options for Round III judiciously.;
- (k) Float options are not available for the seats allotted in this Third and Final On Line Centralized Admission Round.
- (l) Those candidates who have Freezed their admission in the First and Second Round, by opting Freeze Option and Paid the Seat Processing Fees of Rs.1000/- on line (one time Non Refundable) and have confirmed their admission in the admitting College by Paying Stipulated fees of the admitting college, will be eligible to participate for the Third Round as per the provision given in admission rule 9 (3) (ii) Govt. Gazette, Extraordinary, Part-IV-B, Extraordinary No. 113, Dated 5th May 2017.
- (m) Cancellation of Admission of the candidate, who has Freezed his admission in the First round & Second Round on written request of the candidate, will be executed by the Principal as per the Schedule when the admission link is open for the Third Round. Principal will be entitled to deduct the Admission Cancellation Processing Fee of Rs, 1,000/- pay back the remaining balance of the fees to the candidate cancelling the admission. It is the responsibility of the Principal to provide the on line Acknowledgment of Cancellation of Admission to the candidate. After receiving the on line Acknowledgment of Cancellation of Admission candidate should submit this receipt to the newly allotted college in round III, then only college will confirm the admission of the candidate allotted in Round-III. Cancellation of earlier Admission and seeking admission and registering the Admission on the on line portal are the joint responsibility of the candidate concerned and the College concerned.
- (n) The Institutes will verify the documents of the candidates who have exercised the Freeze Option and if there is no discrepancy, the college will confirm the admission of the candidate and accept the fees and give the official receipt to the candidate and upload the status of admission on the Admission Portal. Reporting and Accepting the offered seat will as per the allotment by the Candidate at the Admitted College.
- (o) The candidates whose names have appeared in the First Merit List declared for First and Second Round, chooses to change Personal and Academic information with or without change to Option Form will be eligible for III round but their merit ranking will be considered at the end of the Final Merit list. These candidates will be considered for allocation after the candidates displayed in the Final Merit list.
- (p) Candidates who newly register in the CAP round for the first time are eligible in this III round. NOTE: All the newly registered candidates will be added at the end of the Final Merit list i.e. after the Final Merit list and after the edited merit list of the existing registered candidates as mentioned in above **(c) and (o)**. These candidates will

be considered for allocation after the candidates displayed in the Final Merit list and after the candidates who have been added to merit list based on their edited personal or academic information.

- (q) All newly applied candidates should take care to fill in the details correctly and upload the correct documents, otherwise their name will be put on hold list and these Candidates will not be able to participate in the Third and Final On Line Round of Admission.
- (r) Newly Registered candidates in Third Round will have to verify the documents in allotted college & pay Seat Processing Fee of Rs. 1000/- on line & Pay the Stipulated fees of the college if they have been allocated college and has to Freeze his/her admission by opting Freeze Option Provided in Candidate's login.
- (s) Four new Colleges of Law has been added in the list of approved colleges by DHE. Candidates interested for opting them may refer to the list and add options if they wish.
- (t) Fourth round of Admission is going to be conducted at the Institute Level. The Institutes will be filling in the A-CAP seats and Institute level seats as per the type of the Institute shown in Schedule I and Schedule II page 61-62 of the Information Brochure. Both seats will be filled in as per respective merit by generating merit lists through admission portal.
- (u) Already admitted Candidates of Round-I & Round-II who could not upload the Caste Validity Certificate and or Non Creamy Layer Certificate during the prescribed period 11th August 2018 to 18th August 2018 can upload their Caste Validity Certificate and or Non Creamy Layer Certificate and Edit their personnel details during the period 21st August 2018 to 27th August 2018. They will be placed in the New Merit List of Round –III. Newly Registered Candidates will have to upload the Caste Validity Certificate & Non Creamy Layer Certificate as the case may be during the period 21st August 2018 to 27th August 2018, then only they will be considered in Category Candidates only.
- (v) Already admitted candidates of Round-I and Round-II who choose to edit their Personal and/or Academic details in the Application form, should carefully note that their admissions in Round I/II will automatically get cancelled and their name will be considered in the New Round III Merit List and will be considered for allocation after considering the candidates of the Final Merit List published for the First and Second Round, subject to their completion and approval of the CAP Application Form.
