It is given to the Notice of the Institutes affiliated to the various Non Agriculture Universities in the State of Maharashtra and imparting Education in Law for Integrated Course leading to LL.B-5 Yrs. Degree that vide the schedule cited in the reference above the colleges were directed to register themselves on the Admissions Portal from 21st May to 28th May 2018.

During the period of Registration around only 108 Institutes have registered themselves and completed the registration process.

Some of the Colleges have registered themselves on the On line admission portal but have not completed the registration process and some institutes have not at initiated the process of registration. This means that the Candidates registering themselves for the Admission to the LL.B-5 Yrs. Course will not be able to view the colleges whose registration process is not complete and those who have not registered themselves.

In view of above facts, CET CELL is giving Final opportunity to the Institutes/Colleges to complete their registration process and or register themselves on the on line admission portal and submit the filled in on line application form to Director, Higher Education, M.S., Central Building, Pune 411001 as below:-
